A BYLAW OF THE CITY OF LETHBRIDGE  
PURSUANT TO SECTION 22 OF THE  
MUNICIPAL GOVERNMENT ACT  
TO PROVIDE FOR THE CLOSING OF CERTAIN ROADS

\*\*\*\*\*

WHEREAS Section 22 of the Municipal Government Act, R.S.A. (2000) provides that a Council may pass bylaws for the purpose of closing and selling, leasing or holding the whole or any portion of any street, avenue, lane or public highway;

AND WHEREAS a Plan to be registered in the Land Titles Office for the Southern Alberta Land Registration District includes a portion of Road Plan 4142 JK;

AND WHEREAS a copy of the Notice has been published once a week for two successive weeks in a newspaper having a general circulation in the City of Lethbridge;

AND WHEREAS the City Council has heard the objections of such individuals or interested parties as appeared or made written submission before it at the Public Hearing.

NOW THEREFORE, THE COUNCIL OF THE CITY OF LETHBRIDGE, IN THE PROVINCE OF ALBERTA, DULY ASSEMBLED, HEREBY ENACTS AS FOLLOWS:

1. That those certain parcels or tracts of land in the City of Lethbridge being registered as:

FIRST:  
PLAN 4142 JK, THAT PORTION OF LANE CONTAINED WITHIN LOT 1, BLOCK 2, PLAN \_\_\_\_\_, CONTAINING 0.048 HA (0.119 ACRES) MORE OR LESS, EXCEPTING THEROUT ALL MINES AND MINERALS

SECOND:  
PLAN 4142 JK, THAT PORTION OF LANE CONTAINED WITHIN LOT 2, BLOCK 2, PLAN \_\_\_\_\_, CONTAINING 0.007 HA (0.017 ACRES) MORE OR LESS, EXCEPTING THEROUT ALL MINES AND MINERALS

and illustrated on the attached Schedule "A" and "B", are hereby closed.

2. Upon registration of this Bylaw in the Land Titles Office for the Southern Alberta Land Registration District and the issuance of Certificates of Title to the City of Lethbridge, the City is hereby authorized to hold, sell or lease all or a portion of the said lands.

3. This Bylaw shall come into full force and effect on the date of final passing thereof.
