Subject: Municipal Election Campaign Disclosure and Financial Statement for

the 2013 Municipal Election

Submitted By: Aleta Neufeld, City Clerk,

Recommendation: That the report on the Campaign Disclosure Statements for the

2013 Municipal Election as required under the Local Authorities

Election, be received as information and filed.

Purpose:

The <u>Local Authorities Election Act</u> requires candidates to file with the municipality a disclosure statement in the prescribed form declaring campaign contributions and expenses and the resulting surplus or deficit (if any) by March 1, 2014.

The Act requires candidates to disclose all contributions listing separately any contributions greater than \$100, and any other funding sources and expenses.

If a candidate's disclosure statement shows a surplus, the candidate shall pay the surplus to the municipality to be held in trust for the candidate at a financial institution until the next general election.

The Act also states that any money up to and including \$10,000 paid by a candidate out of the candidate's own funds for the purposes of the candidate's election campaign is not a campaign contribution. Further, if a candidate's entire election campaign is funded exclusively out of the candidate's own funds, the candidate is not required to file a disclosure statement.

Background:

All of the candidates for the 2013 Municipal General Election have filed the required disclosure statement. The Campaign Disclosure and Financial Statements, Form 21, are available for viewing at the Office of the City Clerk and on the City's website.

SECTION TWO - RISK ANALYSIS AND IMPLICATIONS

Legal: A candidate is required by legislation to file with the municipality

a disclosure statement in the prescribed form. The Returning Officer must ensure that all documents are filed and available to

the public.
