| Recommendation: | That the report on Campaign Disclosure and Financial Statements for candidates of the 2017 Municipal Election as required under the <i>Local Authorities Election Act</i> , be received as information and filed. |
|-----------------|---|
| Purpose: | The <i>Local Authorities Election Act</i> requires candidates to file with the municipality a Campaign Disclosure Statement and Financial Statement in the prescribed form (Form 21) declaring campaign contributions and expenses and the resulting surplus or deficit (if any) by March 1, 2018. |
| | The Act requires candidates to disclose: The total amount of contributions of \$100 or less; and, The total amount, as well as the name and address of each contributor whose contributions exceeded \$100; and, Any other funding sources and expenses. |
| | If a candidate's disclosure statement shows a surplus, the candidate shall pay the surplus to the municipality to be held in trust for the candidate at a financial institution until the next general election or by-election. |
| | The Act also states that any money up to and including \$10,000 paid by a candidate out of the candidate's own funds for the purposes of the candidate's election campaign is not a campaign contribution. Further, if a candidate's entire election campaign is funded exclusively out of the candidate's own funds, the candidate is not required to file a disclosure statement. |
| | The Returning Officer must ensure that all documents are filed and available to the public. |
| Background: | All of the candidates for the 2017 Municipal Election have filed the required disclosure statement. The Campaign Disclosure Statement and Financial Statement – Form 21, are available for viewing at the Office of the City Clerk and on the City's website. |
